- Notes:** 1) During June and July, you only pay the base tuition fee of \$499.40 per month.  
 No extended care time fees are paid during these months.  
 2) The August payment consists of the base tuition plus one-half of the monthly extended care fee.  
 This is due to a mid-month start date for school.  
 3) Payment for April & May is only for extended care fees; tuition is paid in full by March 2021.

**Payments:**

Tuition and extended care fees are due on the 1<sup>st</sup> of the month, unless specific arrangements have been approved by the administration. Payments must be made within 5 business days of the due date. A late charge of \$25 will be assessed to a student’s account after this date. Payments may be made with bank transfer (only when invoiced) cash, check, money order, debit card, or credit card (Visa, MasterCard, Discover, and American Express). Payments made with a credit card incur an additional 3% transaction fee.

**Withdrawal Policy:**

If a student is withdrawn prior to the first day of school, a written request for reimbursement of the June and July tuition payments must be submitted by the parent to the School Board. The request must include the reason for the withdrawal of the student and the tuition amount to be refunded. The request will be reviewed by the School Board at the next scheduled meeting. If the student is withdrawn after the first day of school, a month’s tuition may be assessed to the student’s account. **NOTE: The registration fee is non-refundable, regardless of the circumstances.**

**Family Discounts:**

Discounts in yearly tuition are given for multiple siblings enrolled in the five-day program. A deduction of \$400.00 will be taken from the second child’s yearly tuition. An additional \$400.00 will be deducted from each additional sibling’s yearly tuition. Monthly payments will be based upon the tuition balance after the discount has been applied.

**Before and After School Care Additional Information:**

- 1) The number of children in before and after school care is restricted by Texas state licensing. These services are provided on a first registered, first come basis.
- 2) The amounts listed on the first page represent tuition plus the additional monthly fees. A monthly statement will be emailed to your preferred email. Your statement will show each program listed separately (i.e., extended care 5 days per week = \$175.00; after school care 3 days per week = \$85.00). Before school care, extended care, and after school care are offered at reduced days if needed and at an adjusted rate. Please indicate your needs on the student registration form.
- 3) If you choose to increase or reduce the number of days that care is needed, you must notify the school in writing. All changes will be made according to space availability. A \$25.00 administrative fee will be billed to your account for any change made.
- 4) Your child may attend before or after school care on a *drop-in basis, if space is available*. The office must be notified in advance. Drop-in fees are:
  - \$20.00 per day for Before School Care (7:00--8:15 a.m.)
  - \$45.00 per day for Extended Care (noon – 3:15 p.m.)
  - \$35.00 per day for After School Care (3:15--6:00 p.m.)
